#### BANNED SUBSTANCE TESTING

**METHOD:** Samples of the item were extracted and analyzed according to in-house methods for nutritional supplements by qualitative instrumental screen using ultra-high-performance liquid chromatography / high-resolution mass spectrometry (UHPLC/HRMS) in Accordance with ISO/IEC 17025:2017 Validated Standard Operating Procedure. Method detection levels, which vary based on compound and matrix analyzed, are estimated to be in the 2-500 ng/g range for most compounds in most items.

**TESTING MENU:** The testing menu covers over 500 compounds including WADA Prohibited Substances and other prescription, over-the-counter, and illicit drugs not banned in sport. Details are available at <https://www.bscg.org/certified-drug-free-testing-menu-wada-prohibited-list-and-more/>.

**RESULTS:** No compounds from the testing menu were detected in the item.
